You can electronically execute this waiver in advance (in which case you will be asked to confirm that your statements remain true upon entry) You can also deliver the executed form at the Event. However, to avoid delay at entry, we recommend executing it in advance.

Should any of the statements contained in the COVID-19 release waiver not be true at the time of the Event, we cannot allow you to attend.

3. We urge all attendees to learn about and adhere to the Center for Disease Control and Prevention (CDC) guidelines in an effort to avoid the spread of COVID-19, including mask wearing and social distancing, while in attendance at all CREW Miami in-person events.
4. Please do not greet fellow attendees by physical contact.
5. Please do not circulate business cards. For CREW members, you can use CREW Network's CREWbiz to exchange contact information between fellow members. You can also e-mail or text images of business cards.
6. If you need to remove your mask during the Event, please be considerate of others and exit the room to do so or observe the CDC guidelines for sufficient social distancing during the time your mask is off. However, we urge you to keep your mask on at all times.

5. I do not believe that I have been exposed to a person with a confirmed or suspected case of COVID-19 within the last 14 days.
6. I am not currently awaiting test results from a recently administered COVID-19 test.

**Following the statements above I hereby declare the following:**

1. I am fully and personally responsible for my own safety and actions, and assume the risk, while and during my participation at the Event, of contracting COVID-19.
2. With full knowledge of the risks involved, for myself, my heirs and personal and legal representatives, I hereby release, waive, discharge CREW Miami, its board, officers, independent contractors, affiliates, employees, representatives, successors, and assigns from any and all liabilities, claims, demands, actions, and causes of action whatsoever, directly or indirectly arising out of or related to any loss, damage, injury, or death, that may be sustained by me related to COVID-19 while participating at the Event or while in, on, or around the premises or while using the facilities that may lead to unintentional exposure or harm due to COVID-19.

By signing below, I acknowledge that (i) I have read the foregoing Release Waiver and understand its contents; (ii) I am at least eighteen (18) years of age and fully competent to give my consent; and (iii) I am fully aware of the risks involved and give my voluntary consent and acknowledgment to the foregoing as my own free act.
